

This Is Key:

Definition of HOMESTEAD, Black's Law Dictionary:

"The home place; the place where the home is. It is the home, the house and the adjoining land, where the head of the family dwells; the home farm. The fixed residence of the head of a family, with the land and buildings surrounding the main house. See Oliver v. Snowden, IS Fla. 825, 43 Am. Itep. 33S; In re Allen (Cal.) 16 Pac. 319; McKeough v. MeKeough, 69 Vt. 34, 37 Atl. 275; Iioitt v. Webb, 36 N. II. 158; Frazer v. Weld, 177 Mass. 513, 59 N. E. IIS; Lyou v. Hardin, 129 Ala. 643, 29 South.777; Xorris v. Kidd, 28 Ark. 493.

Phase 1

The Homestead Subsidization Act

- Eminent Domain the "18.5 Million Abandoned Properties throughout the U.S."; *Allocate them to "Eco-Wise Homesteaders"*
- Eminent Domain all Rental Spaces; give Title Deeds to the spaces to Tenants via "Buying Out Landlords" (by re-allocating Section 8)
- Orchestrate an "En Masse Homesteading Movement" via Broadcasting "Permaculture <u>and</u> Ethnobotany Skills", & by disseminating *heirloom & native seed* "Homesteading Starter Kits"

Be Aware & <u>Please</u> <u>Care</u>:

<u>Many</u> Civilians are currently <u>suffering</u>_&/or traumatized as a direct result of the housing crises coupled with the ecological distresses of our times (foreclosures, houses & apartments burned in wildfires, homeless shelter <u>overloads</u>, incarcerated family members, etc. etc.)— homeless persons in destitute circumstances with "nowhere to legally sleep <u>or</u> grow food"— renters coping with obscene now frequent rent hikes pushing families from their homes. Families are behind on their mortgage payments in a <u>slumping</u> economy & are worried for their family's safety that their home will be foreclosed on, many people are literally living in "tent cities" in urban areas. Please read the following with an open & loving heart for our human family; we need a solution.

First, A Look <u>Back</u>...

The Original "Homestead Act of 1862"; What Went Wrong

President Abraham Lincoln signed the *Homestead Act* to open what was considered "government-owned land" *(which was <u>actually</u> Native American land)* to small family farmers— *homesteaders*. The act gave "any person" who was the head of a family *160 acres* to try his hand at farming for five years. The individual had to be at least 21 years old, & was required to build a house on the property.

People interested in homesteading first had to file their intentions at the nearest Land Office *(equivalent to the Assessor-Recorder's Office today)*. A brief check for previous ownership claims was made for the plot of land in question, usually described by its survey coordinates. The prospective homesteader paid a filing fee of \$10 to claim the land temporarily, as well as a \$2 commission to the land agent.

With application & receipt in hand, the homesteader then returned to the land to begin the process of building a home & farming the land, *both requirements for "proving up" at the end of five years.* When all requirements had been completed & the homesteader was ready to apply for the Deed, the homesteader found two neighbors or friends willing to vouch for the truth of his or her statements about the land's improvements & sign the "proof" document.

After successful completion of this final form & payment of a \$6 fee, the homesteader received the patent for the land, signed with the name of the current President of the United States.² If a homesteader quit or failed to make a go of farming, his or her land reverted back to the government & was offered to the public again.

The Act was Considered Radical at the Time:

The Act did not define what it *meant* to be the "head of a family"— just the age restriction of twenty-one— making it very egalitarian; it allowed African Americans, persecuted & famine-struck immigrants, & even women a chance to find freedom & success in the West.³

Definition of Egalitarian:

"of, relating to, or believing in the principle that all people are equal & deserve equal rights & opportunities."⁴

Southern <u>and</u> Northern Merchants *Resisted* Earlier Versions of The Homestead Act

Before the Civil War, similar acts had been proposed in 1852, 1854 and 1859, but were defeated by a powerful southern lobby that feared new territories populated by homesteaders would be allowed into the Union as "free states," thereby giving more power to the abolitionist movement. *In addition*, many in the northern manufacturing industries feared the Homestead Act would draw large numbers of their labor force away & into farming. In 1860, *President James Buchanan* vetoed an earlier homestead bill, succumbing to pressure from southern slave-holding interests.

This Version, However, Had A Loophole That was Abused:

This version of The Act offered *an alternative* to farmers via enabling them to *opt* to *buy* their "160 acre settlements" after only 6 months at the reasonable rate of \$1.25 an acre— *this became abused by merchant speculators*— as many became bought out. Much of the land became purchased by individuals acting as a "front" for land merchant speculators who sought access to the vast untapped mining, timber, & water resources of the West. Speculators would offer to pay individuals cash or a share of profits in return for submitting their Homestead Act claim. By 1900, settlers—*legitimate or otherwise*— had gobbled up 80 million acres of land through the Homestead Act, & very little of the space was kept for homesteading. The act was officially repealed by Congress in 1976.⁵

The Homestead Act Was Devastating To Native Americans

To make way for homesteaders, the federal government forced Native American tribes onto reservations. Lincoln's believed Native Americans should forsake their traditional ways of life & *instead* take up farming. Tribes fought vehemently *to protect their tribal lands from white settlement*. Their effort reached its high-water mark on June 25, 1876 in the Battle of Little Bighorn, where *a combined force* of Sioux, Cheyenne, & Arapaho eradicated Col. George A. Custer's Seventh U.S. Cavalry regiment. But their success proved short-lived, & they soon found themselves under the control of the federal government's Bureau of Indian Affairs, & subject to a coordinated campaign to Americanize Indian children in white-run schools.

Preliminary Analysis:

How many people are there?

318.9 million people currently live in the U.S.⁶, *including 81 million families* (averaging 3.13 family members per family)⁷ & ~50,790,000 single adults, couples, orphaned children, etc. ("others").

Initial Assessment: 81 million (families) + 50,790,00 (other) = approximately 131,790,000 living spaces are required to house <u>all</u> families <u>and</u> all others.

How Many Houses Are There?

There are 73,991,995 owner-occupied households, containing 200,617,048 residents.⁸

Initial Re-Assessment: 131,790,000 (total living spaces needed) <u>minus</u> 73,991,995 (owner-occupied households) = 57,798,005 living spaces <u>needed</u>.

There are approximately 18.5 million abandoned properties⁹. "A vacant property becomes a problem when the property owner abandons the basic responsibilities of ownership, such as routine maintenance or mortgage and property tax payments."¹⁰

Crisis Situation:

- Since 2007, banks have foreclosed around eight million homes, averaging 10,000 per month! It is estimated that another eight to ten million homes will be foreclosed before the financial crisis is over.
- **3.5 million people in the U.S. are homeless** (1.35 million & 2.15 million adults¹¹ including 49,933 veterans¹²).
- 2,220,300 adults were incarcerated in US federal & state prisons, & *county jails* in 2013.

Debunking the "there's just too many people" myth:

According to the Environmental Protection Agency, "There are over 3.5 million miles of rivers and streams in the U.S., covering an enormous and diverse landscape."¹³

3.5 million miles converts to 2,240,000,000 acres alongside <u>each</u> river bank.¹⁴. Because there are <u>two</u> river banks, "there are over 4,480,000,000 acres of land in total along America's riversides".

4,480,000,000 (acres) minus 81,000,000 (families in the United States) = 399,000,000 acres left over as wilderness if we were to (hypothetically) "give one acre of land, along a waterway, to every family in the U.S.". 4,480,000,000 divided by 81,000,000 = 55.3.

Therefore:

There would be approximately 54.3 acres of wilderness left <u>in between each</u> family's homestead among such scenario- & that's just along the major waterways! *Everything else would be open space!*

Our organizations' <u>plan</u> is <u>not</u> to give "an acre of land to every family along a major waterway", <u>however</u> we did need to address what has turned out to be a <u>population myth</u>. We have a sustainable population so long as people choose to have 2-3 children per couple & so long as we <u>manage resources</u> wisely.

The Homestead Subsidization Act; *Part 1* "What To Do With America's 18.5 Million Abandoned Houses"



There are 18,600,000 vacant homes in the United States. That's enough for every homeless person to have six.

Summary:

- Eminent Domain America's 18.5 Million Physically Abandoned & Neglected Properties
- Constitute a National Uniform Procedure for filing an Adverse Possession Claim upon such properties for the purpose of "Eco-Wise Homesteading"
- Provide Homesteaders with Heirloom & Native Seed *"Homesteading Starter Kits"* which come *with instructions*
- Subsidize the cost of Basic Improvements for Low-Income persons— *electrical, plumbing, foundation, etc.*
- After 5 years of *Making Improvements*, Cultivating the Land, & *Paying Property Taxes*, Issue a *Title Deed* to Claimants

The Homestead Subsidization Act authorizes Eminent Domain¹⁶ *for use on:*

all properties wherein no persons have resided for 2 or more years, & no persons have maintained routine upkeep during that time *whereby causing* a potential community hazard (*wildfire, mold, etc.*) &/or hazard to the structure(s) *on the property* &/or to surrounding properties *if* left to face further neglect.

Purpose:

To make "the process of making a lawful *adverse possession claim* upon a physically abandoned & neglected property"¹⁷ a safe & simple process, & to administer *uniformity in filing procedures* throughout the States, Nation, & Local Governments. To prevent neglected properties from becoming community hazards. To provide housing to persons seeking to exercise their right to to homestead, & to "fix the nation's *crumbling* domestic infrastructure" in a way which stabilizes & improves local food supplies. To provide "housing & a place to grow" as an unalienable human right, & to allocate resources needed to all people to live mortgage & rent-free lives in a way that benefits <u>all</u> people more than *the current paradigm* is benefiting <u>anyone</u>. To empower people with <u>actual freedom</u>.

How to Claim an Abandoned Property:

Upon request, individuals may receive a "Declaration of Claim of Adverse Possession" Form from any Assessor's Office or through the State Assessor-Recorder's website. Adverse Possession in California is governed under the CODE OF CIVIL PROCEDURE SEC. 315-330¹⁸ (from which The (National) Homestead Subsidization Act is modeled). The form may be filed at any Assessor's Office or online, & a Certified (stamped, signed by Assessor Clerk) copy will then be returned to the Claimant at that time. A Certified Copy of that claim must then be promptly sent by the Assessor to address the State has on file for the Title Holder to provide sufficient time for them to Evict the Claimant ("30 Day Notice") or to file a Claim for Compensation for Property Loss to receive just compensation under Eminent Domain (5 years to file).

When Filing, A Claimant Attests That:

1. The property they're filing appears to have remained Physically Abandoned <u>and</u> Neglected for more than 2 years, & the property will continue to impose an environmental hazard if left neglected.

2. The Claimant is moving onto <u>or</u> has moved onto the property with intent to a.) make improvements on the property, b.) cultivate the land to grow a sufficient food supply, c.) pay property taxes in a timely manner d.) uphold all rights & responsibilities of a title holder.

3. They are now in lawful possession of the property, with intent to fulfill *the above requirements* for perfecting a lawful Adverse Possession Claim.

Creating a Practical *Uniform Procedure* Which Ensures "Equal Protection of The Laws" to Claimants *and* Title Holders:

Under The Homestead Subsidization Act, *upon filing*, an injunction is automatically applied to protect the Claimant's estate, thus indicating to authorities *why* the Claimant *is* living on, & *how* they are in lawful possession of the property. The *property tax bill* will now be sent to the *Claimant* instead of to the Title Holder.

Definition of Injunction:

"an order from a court of law that says something must be done or must not be done"¹⁹

Notice

Although "making an adverse possession claim" *is* on the books in all 50 States, local customs including *prejudice* have been used in recent years to violate the rights & safety of adverse possession claimants; The Homestead Subsidization Act seeks to mitigate such injustices *and* to extend "equal protection of the laws" (14th Amendment) to all persons through applying the "automatic injunction" which occurs via the Claimants initial filing.

Subsidize Basic Improvements for Low Income Persons

May present the Certified Copy of their Declaration of Claim of Adverse Possession to their *Case Worker* at the Human Resources Department²⁰ to indicate they're "opting to homestead". In such cases, vouchers are to be allocated to Claimants for use in covering costs of basic improvements *electrical, plumbing, foundation work, & other essentials required to* "bring the building up to code".

Solar panels & other sustainability measures are *also* to be subsidized to aid Claimants via switching subsidies from natural gas, oil, & other forms of extractive industries over a period of time (*asap*) until "energy independence" throughout Towns, Cities, & The Nation is achieved.

Contesting A Claim; for Title Holders:

Under The Homestead Subsidization Act, Title Holders have six months to perform a Lawful Eviction ("30 Day Notice") with the Claimant. Following such Eviction, the Title Holder must then provide evidence of such Eviction to the County Assessor-Recorder. If a Title Holder provides evidence they were unable to Evict the Claimant within the 6 month time limit (hospitalization), they may instead have up to one year to perform such Eviction. When a Declaration of Claim of Adverse Possession is filed, a Title Holder has up to five years to file a "Claim for Compensation for Property Loss" (Tort) with the State Assessor in order to be financially compensated for any immovable property loss (buildings & land, <u>not</u> "movable property" such as furniture, etc.) caused by The Homestead Subsidization Act. Such Claim/Tort may be requested from any Assessor's Office <u>or</u> through the State Assessor-Recorder's website.²¹

All Properties Filed in This Manner Are Legal Homesteads

And thus are protected from executions of foreclosure & forced sale so long as they're occupied as a home²² (see page 4).

Re-Assessment: (see page 8 for Initial Assessment) 57,798,005 (total living spaces needed) <u>minus</u> 18,500,000 (neglected properties used <u>wisely</u>) = 39,298,005 total living spaces needed to house population.

Sections 323 & 325 of the CALIFORNIA CODE OF CIVIL PROCEDURE define "statutory requirements" for *two different scenarios* for "perfecting an adverse possession claim":

When claiming a title "founded upon a written instrument": 323. For the purpose of constituting an adverse possession by any person claiming a title founded upon a written instrument, or a judgment or decree, land is deemed to have been possessed and occupied in the following cases:

1. Where it has been usually cultivated or improved;

2. Where it has been protected by a substantial inclosure;

3. Where, although not inclosed, it has been used for the supply of fuel, or of fencing timber for the purposes of husbandry, or for pasturage, or for the ordinary use of the occupant;

4. Where a known farm or single lot has been partly improved, the portion of such farm or lot that may have been left not cleared, or not inclosed according to the usual course and custom of the adjoining country, shall be deemed to have been occupied for the same length of time as the part improved and cultivated.

When claiming a title "founded upon a written instrument":

325. (a) For the purpose of constituting an adverse possession by a person claiming title, not founded upon a written instrument, judgment, or decree, land is deemed to have been possessed and occupied in the following cases only:

- (1) Where it has been protected by a substantial enclosure.
- (2) Where it has been usually cultivated or improved.

(b) In no case shall adverse possession be considered established under the provision of any section of this code, unless it shall be shown that the land has been occupied and claimed for the period of five years continuously, and the party or persons, their predecessors and grantors, have timely paid all state, county, or municipal taxes that have been levied and assessed upon the land for the period of five years during which the land has been occupied and claimed. Payment of those taxes by the party or persons, their predecessors and grantors shall be established by certified records of the county tax collector.²³

The Homestead Subsidization Act; Part 2

"Give Rental Spaces To Tenants; Buy Out Landlords"

Summary:

Eminent Domain all Rental Spaces in order to provide Title Deeds to those Spaces to the Tenants; for all purposes, those spaces are considered the Tenants' Homestead. Section 8 will be re-allocated over a period of time in order to "Buy out Landlords" so that Landlords receive "the same amount they've received in rent" for the next 20 years. Once Landlords are bought out, U.S. Taxes will be reduced by more than \$20 Billion per Year via no longer having to pay for Section 8. Eventually Tenants who require more space may apply for a Land Grant for the purpose of Homesteading.

How Many Rental Spaces Are There?

There are 43,267,432 renter-occupied households, containing 110,175,847 residents²⁴, & 3,213,000 vacant rental units.²⁵ 43,267,432 (renter-occupied households) <u>plus</u> 3,213,000 (vacant rental spaces) = 46,480,432 total <u>rental</u> living spaces available.

Reassessment: 46,480,432 (total rental living spaces) <u>minus</u> 39,298,005 (total living spaces needed to house population) = we currently have ~7,182,427 more living spaces than is needed to house the U.S. population!

Renter occupied structures include:

- Single-Family Units: 15,194,827 households, containing 47,652,188 residents
- 2 to 4 Units: 7,777,641 households, containing 19,008,529 residents.
- 5 or More Units: 18,299,474 households, containing 37,831,895 residents.
- Mobile Homes: 1,955,026, containing 5,608,285 residents
- **Other:** 40,464 households, *containing* 74950 residents²⁶

Note: The <u>vague</u> category of "5 or More Units" <u>also</u> represents large complexes <u>and</u> "rental towns"— such as Stuyvesant Town-Peter Cooper Village²⁷ in New York City (right photo), which consists of 110 residential buildings & 11,250 apartments. In cases like these, generally all rent from <u>each</u> tenant is allocated to a single Title Holder's estate <u>every month</u>, while tenants are forced to run "rental treadmills" or become displaced!

Getting To Know Your Circumstances:

Many owners of rental complexes have their accounts set up to "autopay" accountants, property managers, property taxes, and the bank account of *their estates* so that *they* don't actually have to "work" for their exorbitant monthly income. This has created a situation where *some* people are born into obscene wealth & have a vested interest in keeping people from getting ahead, while others are born into families who are essentially "rental slaves". Here's a diagram of *the power structure of rent*:



Title Deed Holder hires Property Managers, Accountants, etc. to receive "unearned income", often used AGAINST Tenants via influencing legislation which keeps them financially burdened. Tenants prevented from "living sustainably". **Title Holders** "hand down the estates" to their heirs, who "inherit the labor of the rental class", who "runs on treadmills".

Each occupied rental unit supplies the Title holder with ~\$500-2000 per month.

Land Holdings:

10% of the population owns 82 percent of the real estate (and 81 percent of the stocks and 88 percent of the bonds), & the top 5% of landowners (not five percent of the total population) own 75% of <u>that</u> land!²⁸





<u>Rental Class</u> Kept In Perpetual State of Dependence:

- *Half* the tenants nationwide pay more than 30 percent of their actual income in *rent*.
- One in every *four* renting households spends *at least* 50 cents of every dollar they earn on rent.
- It's considered the worst time in 36 years to be a renter— the highest *cost* burden <u>recorded</u> by Zillow since they began tracking the figure in 1979.³¹
- Currently Tenants *usually* pay \$500-\$2000 per month in rent, while *Property Owners* only tend to pay \$500-\$2000 per year in Property Taxes *comparatively*.



How The Nation is Suffering from "Too Much Rent":

There is no production of resources (no generation of GDP) through paying rent; the same money used to pay rent could instead be used to help families live sustainably & get ahead in life. A "rent-dependent society" bogs ALL of us down & keeps us ALL from getting ahead via keeping our nation "strapped in debt" while GDP that IS produced by our nation's labor force is usurped by business owners who give "tax-deductible donations" to avoid paying taxes, thus preventing the U.S. from being able to pay off its debt or from meeting the needs of Citizens. Instead of working for a government "by & for the people", we're being forced instead to work to create a large profit for a few individuals.



Our stance is that "even where landlording is being done appropriately (according to current laws), it must be abolished". Rent <u>is</u> slavery, & today is an unneeded user service. A person should <u>not</u> have to pay \$500-\$1,000 per month to another person so that "when the plumbing breaks down the landlord will call the plumber"; people can call their own plumbers, electricians, & pay their <u>own</u> property taxes; <u>not paying rent</u> will save most Americans thousands of dollars per year. U.S. Title Deeds were all forged unconstitutionally; there is no signed contract with the local Native American nation attached to the deeds, & even when there is it was a case of extortion. Let us recognize & honor <u>the truth</u>. Let <u>real</u> freedom ring!!

Logistics:

"Eminent Domain"⁴² will be utilized to "*Take* All Rental Spaces" & "Give *New* Title Deeds to the Rental Spaces to the Tenants who <u>inhabit</u> those spaces" via "Re-Allocating the \$20 Billion per Year (plus State <u>and</u> local subsidies) we currently spend via taxes to fund Section 8" in order to "Buy Out Landlords" so they'll receive "the same amount they currently receive from *rent* for the next 20 years". *This* gives us a strategy to *eventually* "reduce taxes by over \$20 billion per year" in a way that won't cause economic collapse, whereas currently there <u>is no plan</u> to get off our perpetual dependence on "paying for Section 8" <u>and</u> the unsustainable living conditions that come with it. Doing It Morally Right This Time:

A great deal of food can be produced using a small area of land! Soon WildWillpower.org will begin broadcasting step-by-step instructions for developing "an ecologically-beneficial⁴⁴, wildfire-preventing⁴⁵, high-product output homestead⁴⁶" via "combining permaculture techniques <u>with</u> traditional Native American skills. We're working with <u>and sponsoring</u> Native American teachers in order to "do the homesteading movement right this time"!

Homesteading Starter Kits:

We're producing Homesteading Starter Kits which include "native & heirloom seeds". For instance— one kit contains "leafy greens which require similar care", another contains "full sunlight, low water plants"— & so on. Kits also include "instructions for highly-efficient gardening techniques using native & heirloom flora & fauna"— such as The Double Planter Technique for growing yams & potatoes (shown at right).

Highly-Efficient Gardening Techniques, one more example:

Our generation did not choose to break the treaties, but our generation <u>can</u> choose to do the best we can with what we've got to make things as best as we can for *all* people & coming generations. Wild Willpower purchases *many* of our heirloom seeds *directly from tribes*, so "getting Homesteading Starter kits through Wild Willpower" *also* is a way to help support Native American Tribes.

"The 3 Sisters"

"The 3 Sisters" method of growing corn, beans, & squash together is a form of "companion planting" (when done properly), this technique has been performed for thousands of years by several Native American tribes, including the Haudenosaunee people (called "Iroquois" by the French), the Tewa, the Anasazi, & others. a wise, simple form of highly-productive, renewable resource acquisition:

- 1) Plant the corn after danger of frost has passed.
- Plant the pole beans when the corn is 5 inches high.
- 3) Plant squash seeds one week later.

The beans hang off the corn leaves, and add nitrogen to the soil, which the corn (especially) uses.

> Corn, beans, & squash together as a dish is a form of "succotash".

The large leaves of the squash help keep the moisture in & the weeds from growing up, amounting to less work, less water usage, & greater yield!

A Wise, Drought Tolerant Solution To Vastly Increase Healthy Production:

Combining Permaculture & Ethnobiology:

Wild Willpower is broadcasting "how to to harvest the following industriallyviable Forest Products using Positive Impact Harvesting Techniques⁴⁷, & <u>then</u> "how to process them with the help of *de-shellers, oil presses, grain mills, & highlyefficient traditional Native American processing techniques"* in order to model what "a renewable, production-based resource management system which simultaneously <u>prevents wildfires</u>" actually <u>looks like</u>. - Oak trees {*Quercus sp.*} produce 4.5 tons of nuts per acre!⁴⁸
- There are several ways to process them into nutritious flour; *the raw nuts can be processed into flour within 20 minutes!*
- Industrial de-shellers, grain mills, & oil presses expedite the oncetedious process of producing acorn flour.
- Acorns are a complete protein by themselves, *containing all 9* essential amino acids! <u>High in calcium & potassium</u>.⁴⁹
- Acorns produce a rich, buttery oil similar to olive oil— with nutritional value similar to coconut oil.

Special Thanks to Richard "Lonewolf" Legan!

Lonewolf *dedicated his life* to recovering the knowledge of his (Cherokee, Lakota, & Northern Chevenne) ancestors, as well as any "traditional plant knowledge" he could learn from people of other tribes he'd meet as well. He applied that knowledge- found what worked best through trial & error, & spread his passion for "living with the Earth" to people around him. "When all my cousins would go off & play, I stayed behind with the elders. I watched all my friends & family get 'sucked into the system'- they all got indoctrinated. Most of my friends today & those that you see in the Pow Wow- they wouldn't last a week out in the wilderness- not one week!" Lonewolf isn't a bully when he says these things; he's a man who has been in real survival situations & learned not to be naive when it comes to what conditions can occur up on the mountain. "I've seen it go from sunny to all of

the sudden the clouds are rolling in & there's a <u>snowstorm</u>! You have to be ready. Most peoples' situation gets worse every day. My situation gets better every day-more bedding-better firepit-better shelter-better food-<u>everything</u>. Every day <u>better</u>."

When his U.S. Army superiors *witnessed firsthand* Lonewolf knew *more about survival* than they did, *he was co-opted* & began teaching military.⁵⁵ He's taught U.S. combat infantry units & military police, Search & Rescue units, California Native Plant Society, Bakersfield College, California State University Bakersfield & Stanislaus, Bakersfield City School District, Kern High School District, Sherman Indian High School, & Pomona College with the Pitzer Native American Pipeline— *church groups*— as well as *tribes, nations, & clans over* the years. He founded Survival Training Schools of California⁵⁶ in 1983, & has been featured on several news programs & articles.⁵⁷

"The older I got, the more he realized God had put me here in a special position. I'm just going to keep teaching till I die- *teach teach teach teach- that's what I'm here to do!*" He studied plant books, attended & danced at *every* Pow Wow ceremonies he could attend, & carries unique cultural insights wherever he is. "Lonewolf's Survival Kit"⁵⁸ was *compiled by him* after years of *in field* gear testing. Wild Willpower plans to offer his publications & recommended gear, with proceeds benefiting the furtherance of the campaign <u>and</u> adding to his estate. Lonewolf is unable to offer classes at this time.

- watch videos of Native American teachers⁶⁰, mycologists⁶¹, lichen specialists, & other ethnobiologal experts who are sharing otherwise "lost knowledge" *with the world*.
- enable Citizens to coordinate legal wildharvests via indicating on "Special Forest Product Permits"⁶² (& the like) that the harvester "will always use positive impact harvesting techniques & wildfireprevention techniques as described on WildLivingSkiils.org". Our <u>Plan</u> To Build The "Database & App":

Step One: Modeling The Movement

Once we've established a rent-free piece of land to model & continue to build the movement from, a vehicle (preferably a RAV4 from Toyota of Marin⁶³), & printing supplies (\$1,000 needed to get started), we'll begin modeling and broadcasting "how to homestead via combining permaculture <u>with</u> ethnobotany", we'll then embed the footage <u>and</u> photos throughout www.WildWillpower.org and www.WildLivingSkills.org as a mode of First Amendment expression to help The People.

Step Two: Create "Model Database Entries"

Database entries inside the *Database & App* include the following categories:

- **1.** Location Summary
- 2. Identification Characteristics
- 3. Edible, Medicinal, & Utility (soap, rope, wax...) Uses
- 4. Positive-Impact Harvesting Techniques
- 5. "Other" (Interesting Facts)

Soon we'll create 5 "model database entries" for each of the following categories: Plant, Shrub, Tree, Vine, Lichen, Moss, Alga, Grass, Mold. The website will be designed to co-process information throughout the Location Summary and Identification Characteristics sections in order to narrow down search results from before the time you begin your search. For instance, if you're trying to identify "a blue flower" on a hilltop at 3000 ft. elevation, there may only be one or two "blue flowers" growing at your location & elevation at that particular time of year—which enables you to identify the species within only two or three simple questions. A Database built in this way is the first step to building a later version that could be used "to identify via taking a photo".

Step Three: *Hire A Skilled & Honest Online Programmer*

This is *one* section Wild Willpower requires help in "finding the right person". We need to get The Wild Living Skills Database & Smartphone **App from operating "the way it does now**"⁶⁴ (currently best viewed on desktop) computers) to the way its being <u>designed</u> to operate.⁶⁵ The Database & App is a gift for humanity & the coming generations; its the combined knowledge of all our <u>ancestors</u>! Its really more of an *inheritance* than a gift, & it is our *belief* that this inheritance is *due to all persons forever*— *never to be lost again!* Actually, *its never been brought together* like this— which *to us* is a very beautiful & uniting thought! This is where philanthropists come in; if you've got it in your account, please just *help us out*. So far we've put everything together on food stamps & street performing; imagine how good of a job we can do when we have a little bit of funding, comfort, & trust. We promise to do our best, & we're bound to find a developer who's ready to approach this project with the same spirit we are. We would like to help provide a healthy stipend to them for doing this important project. We currently expect to be ready to work with a developer by 2017 assuming we have our needed resources so we can move this project to where it needs to be *before* that time.

Step Four: Pay Biological Society Members to Compile Database Entries for Use in Building the 'Database & App'







We're building a platform everyone is going to appreciate by making sure this site/app *includes* otherwise-unbroadcast knowledge to ensure people get all the facts:

Animal-friendly, plant-based alternative "wild foods" which contain *iron*, *calcium*, *B12*, *protein* (all 9 essential amino acids), fat, Omegas 3, 6, & 9, & other need-to-know plant & mushroom-based alternatives.⁶⁸

- Historical records of vegan civilizations around the world— *Choctaw Native Americans*⁶⁹, *Cathars*⁷⁰, *Pythagoreans & Early Grecians*⁷¹, *Buddhists & Jains*⁷², & *many others*.
- Cases of *wild animal communication:* we've begun *compiling* documentation of people living *peaceably among the wild* with so-called "dangerous animals" *just to get you thinking.*
- Although Wild Willpower doesn't broadcast hunting or trapping skills, we would like to broadcast *how to procure fallen animals* via utilizing *traditional Native American techniques— leather, rawhide, fur, sinew, soaps, & other procurable materials.*
- We'd like to broadcast traditionallyaccurate animal meanings & stories for the sake of uniting intercultural knowledge so that it may be truthfully (to traditional knowledge rather than hearsay) & respectfully broadcast so that everyone may have the opportunity to connect with & learn from this knowledge what they will.

Step Five: We'll Pay You To Help Build The Database

Once the foundation of the Database & App are operating as designed, people will be able to *use the website/app* to identify biological organisms within less than 5 questions. Once a person has *identified a species*, if we don't already have identification-friendly photos uploaded onto the page, users can *upload their own identification-friendly photos* (*directions will be given via the site*). Once verified, an amount of \$25 per photo will be deposited into the user's account! If the person submits significantly *better* photos than the ones we've got, the *old photos will be archived*, & the new ones will be posted instead. Money will then be deposited into *that* user's account. Supporting Wild Willpower helps to support the building of The Wild Living Skills Database & Smartphone App in this way.




Helping Companies To "Make The Transition" So They Can Become Bright Green Sponsors




Logistics:



8000-3700 B.C.: Haltamti ("Elam") & The Birth of Economics

nerians Called Them Elamites. They Called Themselves the Haltamti:

From 8000-3700 BC the Haltamti lived among The Fertile Crescent between the Tigris & tes rivers; they are accredited with having developed the first wooden wheel and the first sailboat: the advent of the wheel "in turn" led to the advent of the handcart. & then the ox cart, which was used for ploughing fields. Along with the use of irrigation technique introduced from the Vinčan people of the Balkan Penninsula (Greece/Ancient Grecians), the ox cart enabled the Haltamti to develop the most successful agricultural operation even organized, giving them a great surplus of resources compared to the surrounding urbantype developments ("cities") to which the knowledge of agriculture would spread.

Copper was first mined & metallurgy (metal-working) first performed by the Vinča people, the oldest Veolithic culture in South-eastern Europe, between 5,500–4,500 BC.¹⁴ The intricate irrigation systems used for their crops also helped them to be able to manage & negotiate an expanding inter-regional trade network between communities, called "commerce". Copper (eventually, in 5000 BC) & other materials would be traded from the Vinčans to the Himalti in exchange for grains, meat, crops, pottery, & tools

Eventually tin would be mixed with copper to produce the more powerful bronze. Tin was likely imported from The British Isles at the time because the word "Britain" translates "Land of Tin", from the Phoenician (see Ch. 2) & Hebrew words "ba-ra-ten-ae" (same in both languages)5. Copper and irrigation techniques found their way to Himalti around 5000 BC.



Present Your Best Self

First impressions are so important. The way you're dressed, your cleanliness, how you carry yourself— your confidence, consideration, & kindness all play a part in how people respond to you. Really listen to people- & if you don't know the answer just be honest with them. Some people may try to antagonize you; please don't bite the worm! They probably want you to lose your composure &/or confidence. Just hold your head high & keep moving. In our experience, way more people sign the petitions than argue against them, & many who argue do it in a way which wastes your time <u>or</u> preferably educates them once you get the hang of it & begin learning all the material! Its okay to tell them to move on & to stop harassing you if necessary.

Great Wisdom: Keep Your Composure With Officers &/or Security Guards

The key is to remain civil; <u>withhold</u> your anger or it may be used against you in a court of law or within the officer's decisions. You may be *fearful* or have disdain for officers due to past trauma, however it is important to do your best to just be courteous with them, & also to be assertive but *helpful*. Please consider: They may not be very well educated (or <u>trained</u>) on "all the law codes", <u>and</u> they may have deep psychological issues with anger— but consider them "wounded" & not "evil". Here's why...

It is quite possible the officer was not trained properly in defending civil rights & liberties, & that <u>they were denied knowledge</u> which was used by (local) legislators (for instance) in order to "turn officers & civilians against each other". <u>The real issue</u> is "the conflict between the *commercial* & the *civil codes*"; what if the officers were being taught to enforce "commercial codes", & being *denied the knowledge* that civil codes even *exist*? What if *the confusion* is being used to "divide & conquer" while our country is just turned against itself? And what by knowing the law system we can *cure the root cause of this problem*?

That said— consider yourself about to be <u>blessed</u> & <u>educated</u>! Use this opportunity to challenge yourself to become a better teacher, & to "reach out". Remember when Jesus said while he hung on the cross, "Forgive them, Creator, for they know not what they do." (Luke 23:34) If you have knowledge the officer is unaware of, it is possible for you to bring <u>knowledge</u> to them that they have been denied, <u>and</u> they may <u>really appreciate</u> being shown that according to the law system they swore to uphold during their Constitutional Oaths of Office, that they are <u>supposed</u> to "do the right thing" & "protect the civil law system from overreach of commercial codes; they may have been instructed to do the opposite by those who pay them.

The Conflict in The Codes; What American Must Know

Because most incorporated municipalities ("Cities") require you to purchase a *commercial permit* in order to be able to set up a booth & do outreach, <u>be prepared</u> to speak with officers who may approach you & assume you are performing *commercial* activity. First Amendment activity however is *non-commercial* activity, & thus it is *not governed under Admiralty Law.; its governed under Common (Constitutional) Law.* The officer, however, must uphold commercial laws <u>and</u> civil laws— which makes "being an officer" a very difficult duty which requires "a just ruler" of every officer! It is a position of *honor*, & thus *honesty.*

What Is It About The Commercial Code Which Causes Confusion?

Under the Uniform Commercial Code ("UCC")— which <u>every</u> (County & City & Non-Profit & For-Profit) Corporation signs into via the "UCC Connect portal" on their Secretary of State's Website⁸⁶ (this exists in all 50 States), there is a single code the public needs to know about:

UCC § 1-308. Performance or Acceptance Under Reservation of Rights.
(a) "A party that with explicit reservation of rights performs or promises performance or assents to performance in a manner demanded or offered by the other party does not thereby prejudice the rights reserved. Such words as "without prejudice," "under protest," or the like are sufficient."

This is important because the United States Oath-keeper is employed by the County or City Corporation ("Artificial Person"⁸⁷) who hires them so that they uphold—for instance—City & County Ordinances & Codes which are upheld beneath the Uniform Commercial Code, however because the County, City, or Shopping Center Owner (see page 78) have hired a United States Oath-keeper, they contracted in <u>knowingly & willingly</u> with an organization who honors & protects the protection of civil rights at the very forefront of its nation's design, & by doing so that organization has too affirmed their commitment to the same, & to the continued improvement upon the general welfare of all persons within that realm under The Preamble of The Constitution which includes upholding treaties, respect, & land & civil rights defense to Native American nations as well under The Treaty Clause (page 178). <u>Reserve your rights; make known your rights under United States Law.</u>

You Do Not Need A Commercial Permit In Order To Perform First Amendment Activity.

Local policy &/or security guards &/or shopping center owners &/or business owners <u>may</u> disagree at first *or* not know this, but if officials violate your Civil Rights, you *can* sue the County *(if its the Sheriffs)* or City *(if its the Police)*, and the officer could very potentially be put in federal prison if they choose to violate your civil rights if they arrest or intimidate *(I have been accused of panhandling, & also of "trespassing" by officers in the past, so now I carry printed copies of case rulings with me from* directly off government websites, for instance here is a page I keep with in my binder so that if an officer stops me, there is a copy of it *in my possession* to they have a chance to learn that this statute exists: http://uscode.house.gov/view.xhtml? req=deprivation+of+rights+under+color+of+law&f=treesort&fq=true&num= 1&hl=true&edition=prelim&granuleId=USC-prelim-title18-section242

Title 18 United States Code 242 (1) **Deprivation of Rights Under Color of Law**

"Whoever, under color of any law, statute, ordinance, regulation, or custom willfully subjects any party in any state, territory, or district to the deprivation of any rights, priveleges, or immunities secured or protected by the Constittion or the laws of the United States, or two different punishments, pains, or penalties, on account of such party being alien, or by reason of the party's color, race, etc. than are prescribed for the punishment of citizens, shall be fined \$10,000. Under this title or imprisoned but not more than ten years, or both."

§1985. Conspiracy to interfere with civil rights

(3) Depriving persons of rights or privileges:

If two or more persons...conspire or go in disguise on the highway or on the premises of another, for the purpose of depriving, either directly or indirectly, any person or class of persons of the equal protection of the laws, or of equal privileges and immunities under

the laws; or for the purpose of preventing or hindering the constituted authorities of any State or Territory from giving or securing to all persons within such State or Territory the equal protection of the laws...if one or more persons engaged therein do, or cause to be done, any act in furtherance of the object of such conspiracy, whereby another is injured in his person or property, or deprived of having and exercising any right or privilege of a citizen of the United States, the party so injured or deprived may have an action for the recovery of damages occasioned by such injury or deprivation, against any one or more of the conspirators.

Another good statute to have printed out is *Title 42* of the United States Code §1985 "Conspiracy to Interfere with Civil Rights"; it can be printed *directly from* The Office of Law Revision Counsel *of the House of Representatives* website at *this* web address:

"Conspiracy to Interfere with Civil Rights" & related statutes were established pursuant to the Civil Rights Act of 1871, also called the *Ku Klux Klan Act*, an Act of the 42nd United States Congress which empowered the President to suspend the writ of habeas corpus (a type of court order which demands the release of an alleged criminal based upon the "lack of sufficient grounds" to hold them) to combat the Ku Klux Klan (KKK) & other white supremacy organizations which were running the local (County & City) governments of the incorporated (Corporate) Counties many owned & operated &/or held share in. The act was signed into law by President Ulysses S. Grant on April 20, 1871. The act was the last of three Enforcement Acts passed from 1870 to 1871 during the Reconstruction Era to combat attacks upon the suffrage (voting) rights of African Americans.

This legislation was *asked for* by President Grant & passed within one month of the president's request for it to Congress. His request was a result of the reports he was receiving of widespread racial threats in the Deep South, particularly in South Carolina. He felt that he needed to have his authority broadened before he could effectively intervene. After the act's passage, the president had the power for the first time to both suppress state disorders on his own initiative *and* to suspend the right of habeas corpus. Grant did not hesitate to use this authority on numerous occasions during his presidency, & as a result the first era KKK was completely dismantled & did not resurface in any meaningful way until the first part of the 20th century. The influence of the legislation *today* is that several of its provisions still exist codified as *statutes*.⁸⁸

Any Building Which Contains 3 or More Businesses That is Open To The Public is Considered A "Shopping Center", & First Amendment Activity *Is* Protected At Shopping Centers

(yes, even privately-owned shopping centers!)

PruneYard Shopping Center v. Robins

447 U.S. 74,100 S. Ct. 2035, 64 L. Ed. 2d 741,1980 U.S.

Brief Fact Summary: Students wanted to distribute literature at a large shopping center, but the owners wanted to deny them access to the property.

Synopsis of Rule of Law: A state law which requires owners of large shopping enters to allow members of the public to enter their property to distribute petitions does not constitute a taking of property, even though the law limits the property owner's right to exclude others from its property.

Facts: PruneYard (Appellant) is a shopping center open to the public. It has a policy not to permit any visitor or tenant to engage in any publicly expressive activity, including the circulation of petitions, which is not directly related to its commercial purposes. High school students (Appellees) set up a table in a corner of Appellant's courtyard and distributed pamphlets in support for their opposition to a United Nations resolution against Zionism. A security guard told them to leave. Appellees seek to enjoin Appellants from denying them access to the property to circulate their petitions. Appellants content that their constitutionally established rights under the Fourteenth Amendment to exclude Appellees from adverse use of their private property cannot be denied by invocation of a state constitutional provision or by judicial reconstruction of a state's laws.⁸⁹

Note: Be sure not to block customer traffic *or* be pushy. *Let people approach you instead of approaching them*. Imply *choice* in *how you speak*. Pique peoples' interest instead of blasting them with information: "*Did you know acorns are edible?*" "*Petitioning for housing solutions for people.*"- *be creative & honest & kind.*

You Do Not Need A Commercial Permit To Gather Signatures <u>or</u> To Collect Campaign Contributions You may collect campaign contributions while out gathering petition signatures & promoting the cause. "Giving money to support political causes" is protected under The First Amendment and Federal Elections Commission ("FEC")⁹⁰ ruling Buckley v. Valeo⁹¹.

Here's an excerpt from the Buckley v. Valeo ruling as posted on *The Amendment Gazette's article*, "How Spending Money Became a Form of Speech"⁹²:

"A restriction on the amount of money a person or group can spend on political communication during a campaign necessarily reduces the quantity of expression by restricting the number of issues discussed, the depth of their exploration, and the size of the audience reached. This is because virtually every means of communicating ideas in today's mass society requires the expenditure of money. The distribution of the humblest handbill or leaflet entails printing, paper, and circulation costs. Speeches and rallies generally necessitate hiring a hall and publicizing the event. The electorate's increasing dependence on television, radio, and other mass media for news and information has made these expensive modes of communication indispensable instruments of effective political speech."

Keep Records

All money that comes to you needs to be recorded. Keep a journal to write the date & hours that you were out collecting signatures, promoting, making signs, etc., & how much you gathered in contributions during each session. If you make any purchases while doing campaign work (printing cards, purchasing meals, bus tickets, etc.), paperclip the receipt onto the page for that day; this helps provide evidence that you are actually doing campaign work so you can show officers & prove on the spot that you're not embezzling money (likely you won't need to show them- but if an officer <u>does</u> inquire, it helps to be able to provide evidence on the spot to help <u>them</u> protect <u>your</u> rights against whoever complained against you).

All money that comes to you may be used to help you *further the campaign;* it can be used to supply you with your <u>needs</u>—food, hygiene products, printing costs, & other living expenses as the campaign moves forth. This gives you the freedom to "get paid for helping the nation" while we continue developing the websites, publications, & moving the campaign forward from our end. If you find yourself doing exceptionally well in garnering support while out gathering signatures, please contact Distance@WildWillpower.org to offer a contribution back to us (we call these "kickbacks" in politics). As we are often spending everything we've got to keep inching the projects forward, we understand if you're unable to kickback right away.

Wild Willpower works on The Honor System.

Note: You can download cards off WildWillpower.org under the "Get Involved" section⁹³; feel free to offer cards to the officers & thank them for their service to our nation & for protecting the peoples' rights. Remember—ultimately you're out here to help feed <u>their</u> families. There should be no need to escalate the situation even though at times you may feel intimidated; just be patient & calm & helpful; *vigilant*.

Ask For Officers' Cards. Get Badge Numbers. Collect Names. Be Respectful & Thank Them For Protecting The Peoples' Rights.

Besides names & badge numbers, write down any identifying characteristics of each officer—*hair color, eye color, ethnicity, etc.* The *reason* is evident on page 85.

Violating Your Rights Is A Federal Crime

The American people <u>should</u> have been taught "how to defend civil rights in court" while we were in high school. However, instead we learned to depend on lawyers & attorneys that <u>most</u> civil rights victims cannot afford. According to my experience & research, many times officers will violate a person's civil rights, <u>knowing</u> that the victim will not be able to afford an attorney— however you <u>could</u> also look at these moments as "an opportunity to get paid for the work of exacting justice via giving the government the authority to squeeze a corrupt officer off the force". If you are violated, contact the ACLU. In our experience, however, the ACLU has never gotten back to us & aided in this way. In this case, you can file your case Pro Se at the Federal District Courthouse. "Pro Se" means "for yourself". You can download a simple-to-use "Pro Se Packet" from The Eastern Federal District Courthouse website here (research the Federal District Courthouse in your area in case there are different local rules at your Federal District Courthouse):

You Have A Right To *Film Officers; We Strongly Recommend* <u>Livestreaming</u> In Case They Steal Your Recording Device!

The following U.S. Courts of Appeals have recognized the First Amendment right to record the police and/or other public officials in the performance of their duty:

•First Circuit: see <u>Glik v. Cunniffe</u>, 655 F.3d 78, 85 (1st Cir. 2011) ("[A] citizen's right to film government officials, including law enforcement officers, in the discharge of their duties in a public space is a basic, vital, and well-established liberty safeguarded by the First Amendment."); <u>Iacobucci v. Boulter</u>, 193 F.3d 14 (1st Cir. 1999) (police lacked authority to prohibit citizen from recording commissioners in town hall "because [the citizen's] activities were peaceful, not performed in derogation of any law, and done in the exercise of his First Amendment rights[.]").

•Seventh Circuit: see <u>ACLU v. Alvarez</u>, 679 F.3d 583, 595 (7th Cir. 2012) ("The act of making an audio or audiovisual recording is necessarily included within the First Amendment's guarantee of speech and press rights as a corollary of the right to disseminate the resulting recording.").

Ninth Circuit: see Fordyce v. City of Seattle, 55 F.3d 436, 438 (9th Cir. 1995) (assuming a First Amendment right to record the police); see also Adkins v. Limtiaco, __Fed. App'x _, No. 11-17543, 2013 WL 4046720 (9th Cir. Aug. 12, 2013) (recognizing First Amendment right to photograph police, citing *Fordyce*).
Eleventh Circuit: see Smith v. City of Cumming, 212 F.3d 1332, 1333 (11th Cir. 2000) ("The First Amendment protects the right to gather information about what public officials do on public property, and specifically, a right to record matters of public interest.").

•The Appellate Division of the Superior Court of New Jersey recognized the existence of such a right in <u>Ramos v. Flowers</u>, Docket No. A-4910-10T3 (N.J. App. Div. Sept. 21, 2012), relying heavily on the First Circuit's reasoning in the *Glik* case.

•The United States Department of Justice has <u>openly stated its position</u> that the *First Amendment protects all U.S. citizens who record the activities of the police in public*, & has intervened in at least one civil rights lawsuit against police officers to support that First Amendment right. See <u>Sharp v. Baltimore City Police Dep't</u>, No. 1:11-cv-02888-BEL (D. Md. Statement of Interest filed January 10, 2012).⁹⁴

If An Officer <u>Steals</u> Your Camcorder Under The Guise of "Confiscating Evidence", They Have Violated

The Fourth Amendment

<u>and</u>

CALIFORNIA PENAL CODE 141(b):

141. (b) A peace officer who knowingly, willfully, intentionally, and wrongfully alters, modifies, plants, places, manufactures, conceals, or moves any physical matter, digital image, or video recording, with specific intent that the action will result in a person being charged with a crime or with the specific intent that the physical matter, digital image, or video recording will be concealed or destroyed, or fraudulently represented as the original evidence upon a trial, proceeding, or inquiry, is guilty of a felony punishable by two, three, or five years in the state prison.⁹⁵

The Fourth Amendment of The Constitution of The United States reads:

"The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."⁹⁶

The Following Excerpt is an from "What Does The Fourth Amendment Mean?" on www.USCourts.gov:

"The Constitution, *through the Fourth Amendment*, protects people from unreasonable searches and seizures by the government. The Fourth Amendment, however, is not a guarantee against all searches and seizures, but only those that are deemed unreasonable under the law."

• Searches and seizures inside a home without a warrant are presumptively unreasonable. *Payton v. New York, 445 U.S.* 573 (1980).

However, there are some exceptions. A warrantless search may be lawful:

- If an officer is given consent to search; Davis v. United States, 328 U.S. 582 (1946)
- If the search is incident to a lawful arrest; United States v. Robinson, 414 U.S. 218 (1973)
- If there is probable cause to search and exigent circumstances; Payton v. New York, 445 U.S. 573 (1980)
- If the items are in plain view; Maryland v. Macon, 472 U.S. 463 (1985).
- When an officer observes unusual conduct which leads him reasonably to conclude that criminal activity may be afoot, the officer may briefly stop the suspicious person and make reasonable inquiries aimed at confirming or dispelling the officer's suspicions. Terry v. Ohio, 392 U.S. 1 (1968) Minnesota v. Dickerson, 508 U.S. 366 (1993)⁹⁷


Step-By-Step; What To Do If Your Rights Are Violated

1. Write your testimony. Write your testimony. Write your testimony. If you contact a lawyer or attorney, they will always want your testimony, so go ahead & write it <u>all</u>, unabridged right away. Keep records of the time it takes you to work on the case— clock your hours. Prosecution for most federal crimes must begin within five years of the commitment of the offense. There are exceptions— some types of crimes are subject to a longer period of limitation.⁹⁸ You've got time— do a good job.

There is an ancient *reason* your testimony must be *written*, & it can be seen *symbolically* within the ancient symbolic statue *we* call *Lady Justice* (*next page*). She's considered The Goddess of Natural Order, & has been "carried through the cultures" for thousands of years: *Greek: "Themis", Roman: "Justitia", English: "Order".*

The Judicial purpose of the "scales" is that "whoever stacks the strongest case" (court orders, evidence, line of reasoning, & list of reasonable demands) into the "scales of justice"— wins. If you go into the courtroom & simply state your case verbally (& if it is not a court of record— I recommend filming, & then filing a Tort on the County if the County Policy denies your right to film), but your opponent files 2 simple court orders along with some evidence, the *judge* will *have* to side with "the side of the scale which has a *standing* case built". *This* is why any ticket citations you are issued from officers should be saved as evidence to stack your case. If the officer (or other person) stacks a paper case against you, & you go in with a verbal defense, but then you will likely be found "guilty" simply because "the officer put more paperwork in the scales". This is because the judge is liable to their decision, & they cannot legally defend their decision on hearsay (rumour) in case their decision goes up for review. To win a case, you will need to stack evidence, cite credible sources for statistics, & place them into context with the circumstances of your testimony. The first step is writing your testimony. If there are any witnesses &/or character witnesses as to your character, it will help the case *immensely* if they each write a testimony in your favor as well. Stack it up.



Ammit lived near the scales of justice in Duat, the Egyptian underworld. In the Hall of Two Truths, Anubis weighed the heart of a person against the feather of Ma'at, the goddess of truth, which was depicted as an ostrich feather. If the heart was judged to be not pure, Ammit would devour it, & the person undergoing judgment was not allowed to continue their voyage towards Osiris & immortality. 

What To Do If Your Rights Are Violated Continued:

2. File a Complaint along *with your testimony* with the Internal Affairs Division of the *main* County Sheriff's *(or City Police)* Station. *This* is the reason you recorded the names & badge numbers & descriptions on page 81, & also asked each of the officers for their cards— it makes it easier to file an effective Complaint.

Important!

When filing *any form*, be sure to request a *stamped*, *signed*, & *dated* copy *back* from the Clerk. *That way* you'll have *evidence* that your Order was filed *on that day* so that your matter is handled in a timely manner *and* you'll have more *evidential paperwork* to "stack in the scales" & show the judge &/or jury in court.

Tort (aka "Liability Claim") Forms; *How To Attain Restitution After Civil Rights Violations Occur*

Restitution:

a.) "returning to the proper owner property or the monetary value of loss. Sometimes restitution is made part of a judgment in negligence and/or contracts cases."

b.) "in criminal cases, one of the penalties imposed is requiring return of stolen goods to the victim or payment to the victim for harm caused. Restitution may be a condition of granting a defendant probation or giving him/her a shorter sentence than normal"⁹⁹

3. Locate your local County Board of Supervisors; *on their website* there should be a "LIABILITY CLAIM" form or "GENERAL TORT" form that you can download (*or pick up from the office if for some reason they don't have it up*), such as *this one* from the Kern County Board of Supervisor's website:

In the section where the claim form reads "amount claimed", write in an additional "\$10,000" *for each officer that was present* for violating Title 18 United States Code Deprivation of Rights Under Color of Law *as seen on page 77.* Deprivation of Rights Under Color of Law calls for a "\$10,000 fine" of which the County is liable to.

When filing the *Tort* at the Board of Supervisors office, again *get your stamped, signed, & dated copy* back from the Secretary. Save this to show the judge &/or jury in court.

Depending on your situation, you may want to cite that you suffered a "personal injury" on both the Tort *and* the injunction, as that *establishes* that this is a *personal injury case*.

Definition of "PERSONAL INJURY" from Black's Law Dictionary.

"A non physical injury that occurs due to wrongful eviction, slander, false arrest or by violating the right to privacy of any person."¹⁰⁰

5. If you cannot find a *downloadable* PDF file for an "Injunction" form, you *should* be able to request an *Injunction Form* at the courthouse. *Otherwise* www.uslegalforms.com offers blank injunction forms here:

Within the injunction, request a "Citizen's Arrest" on each [officer's name] for whichever statutes they violated (beginning on page 77). If you are facing fabricated charges by someone who is abusing the court system, it is likely they were depending on you not to know anything about "how to defend your rights in court". Many people have been *bullied* by people *through* the court simply because *the* actual victim doesn't know how the courts work so they end up being found guilty even though they were innocent! What is happening in these cases of "court abuse" is that they are *expecting* to "stack papers against you", & that you will formulate a weak defense after not being able to find an attorney. In that, they're expecting you to go into court as a *Defendant*, but *instead you're* going to *counteract their plan* by "requesting an extension on the case" from the judge at the Superior Courthouse (it is best to show up to the Clerk of Court's Office & request the delay at least two weeks before the scheduled court date; that is often the rule; do it asap), & then by following this up by filing as a *Plaintiff* in the Federal Court for having a *personal* injury caused to your civil rights, & within your court filing (the injunction form) as part of your "list of reasonable demands"— you *may* find it wise to specify a demand for "Obtaining better protocols for officers in this type of situation, & to train officers as such". This ensures the next person in line is not harmed in the first place, because the County & State now follow new protocol.


Definition of Injunction:

"A judicial order that restrains a person from beginning or continuing an action threatening or invading the legal right of another, or that compels a person to carry out a certain act, e.g., to make restitution to an injured party."¹⁰¹


