

Request for Restitution & *Justice* on behalf of Ms. Smith, & Mr. Tristan & Steff Garrison

An Additional Analysis: Request for Restitution & Justice on Behalf of Ms. Rachel Smith, & Mr. Tristan & Steff Garrison:

WHEREAS Ms. Wilson became *witness to* Title 42 Conspiracy to interfere with civil rights occurring to *Ms. Rachel Smith* who was *not provided equal protection of the laws* during instances of interaction with Kern Sheriff's Deputies (*pages 166-199, 231-243, & 244-246*), & then who was *further violated* after being *not protected on 5-10-2016* by being *cited for trespassing the following day on 5-11-2016*, & being *put out onto the streets at the same time Mr. Byrd & Ms. Wilson were*,

Be It Hereby Recognized:

Ms. Alexandra Wilson is hereby declaring that she has *witnessed* Title 42 Conspiracy to interfere with civil rights take place in a way which caused a personal injury to & harmed the general welfare (*see Preamble of The Constitution of the United States*) **& safety of Ms. Rachel Smith**, & so she is hereby reporting that *Conspiracy to interfere with civil rights* has harmed Ms. Smith. Ms. Wilson believes that Ms. Smith *is due Restitution for recovery & for general relief*, & that Ms. Wilson should *not* be charged with:

§1986. Action for neglect to prevent (*in regards to this case*)

“Every person who, having knowledge that any of the wrongs conspired to be done, and mentioned in section 1985 (*see page 268 for section 1985 Conspiracy to interfere with civil rights*) **of this title, are about to be committed, and having power to prevent or aid in preventing the commission of the same, neglects or refuses so to do, if such wrongful act be committed, shall be liable to the party injured**, or his legal representatives, **for all damages caused by such wrongful act, which such person by reasonable diligence could have prevented**; and such damages may be recovered in an action on the case; and any number of persons guilty of such wrongful neglect or refusal may be joined as defendants in the action; and if the death of any party be caused by any such wrongful act and neglect, the legal representatives of the deceased shall have such action therefor, and may recover not exceeding \$5,000 damages therein, for the benefit of the widow of the deceased, if there be one, and if there be no widow, then for the benefit of the next of kin of the deceased. But no action under the provisions of this section shall be sustained which is not commenced within one year after the cause of action has accrued.”¹

WHEREAS Ms. Wilson became *witness to Title 42 Conspiracy to interfere with civil rights occurring against Mr. Tristan & Ms. Steff Garrison by neighbor Rudy (their landlord) on 6-25-2016 (pages 229-230) via “Unlawful removal of property” (CIVIL CODE section 1983 on page 266) & “Illegal eviction procedures” (CIVIL CODE section 289 on page 249) which Ms. Wilson has witnessed to have caused continued suffering to Mr. Tristan & Steff Garrison & has endangered the safety & welfare of their 4 year old son who was also violated by Rudy's actions:*

Be It Hereby Recognized:

Ms. Wilson is hereby reporting that such crimes *did* occur to the best of her knowledge, & that Mr. Tristan & Steff Garrison are due, *by law, restitution & justice* regarding this instance. This AFFIDAVIT is for the Citizen's Arrest of Rudy & Liz to schedule a hearing to attain *due process* on behalf of the Garrison family *and* Mr. Byrd & Ms. Wilson.

To the amount of *property losses* as well as stress, mental anguish, & for losses caused by child endangerment which occurred as a direct result from actions by their landlord Rudy who *stole* the Garrison family's property *and* the property of Mr. Byrd & Ms. Wilson (page 266).

The Citizen's Arrest is to *also determine* if Rudy & Liz were lawfully renting the property to Steff & Tristan (*see page 230 regarding “why”*).
