### Wild Willpower PAC's *Petition Drive* Launches on May 1, 2018

In case you missed it, The White House now offers *an official platform* for *creating your own Petitions*. According to [WhiteHouse.gov](http://WhiteHouse.gov),<sup>1</sup> if a petition built on their website (called “*We The People Petitions*”) receives ‘100,000 signatures within 30 days’, the White House is legally compelled to respond. *Its time to put this to the test!*

On [www.WildWillpower.org](http://www.WildWillpower.org), each *section* of our national plan<sup>2</sup> contains a downloadable Petition designed to *enact* that section of the plan. These petitions are *also* found within the *Petition Drive* section of the website.<sup>3</sup> At the time we officially *launch* the Petition Drive on May 1, 2018, *We The People Petitions* will be embedded throughout the website both *within the plan* and into the Petition Drive. This will make “*signing all the Petitions at once*” (and learning about them) a streamline process.

Prior to the launch, our campaign team will be working *continuously* to

- upgrade our websites.<sup>4</sup>
- hand out cards & fliers to inform people about the websites, the plan, *and* the Petition Drive.
- collect *physical* petition signatures.

In summary, we'll be doing *everything we can* so that *at the time the drive launches* we can break the *100,000 signatures* mark for *each* petition before June 1. At the end of the 30 day drive, we'll *personally* be filing *all the Petitions* with the U.S. Court of Federal Claims.<sup>5</sup> More information will be coming out about *that* soon, however *first* we want to hear from *you*:

So that *your* thoughts, ideas, & insights are considered & integrated into the plan *before* the drive is launched, please read the plan and send us your questions, thoughts, & ideas.<sup>6</sup> You *will* receive a response, *and*, if your idea is integrated, we'll send you back a link to the page where its been integrated, wherein we'll accredit *you* for your contribution at the bottom of the page. If we have any questions or additional considerations, *we'll get back to you asap*. We're a *grassroots movement*. If you see how important the plan is, please consider joining our campaign team.<sup>7</sup>
